Ashland board authorizes quarterly dividend

WILMINGTON, Del., November 14, 2024, – The board of directors of Ashland Inc. (NYSE: ASH) has declared a quarterly cash dividend of \$0.405 cents per share on the company's common stock. The dividend is payable on December 15, 2024, to stockholders of record at the close of business on December 1, 2024.

As of October 31, 2024, there were 47,109,326 shares of Ashland common stock outstanding.
